Bristol Harbour Lodge & Golf Club is Western New York's premier public golf course. Located in Canandaigua, New York, we have breathtaking views of Canandaigua Lake during the round of golf, and during your breakfast, lunch or dinner following play. *In 2016, Bristol Harbour ranked #6 on Golf Advisor's list of top 20 golf courses in New York State.*

Our course will challenge players of any skill level. The 6,700-yard golf course was designed by renowned architect Robert Trent Jones in 1972. The 18-hole course is well known for its championship layout, and for the amazing views of Canandaigua Lake and surrounding hillsides. Enjoy open views of the lake as you weave through our front nine links

layout featuring tall fescue and strategic bunkering. Then tackle the back nine surrounded by woods and the beautiful backdrop of the Bristol Hills.

Since 2016, we have made many enhancements to the golf course to improve your golf experience, including: bunker renovations, paving the golf cart paths, addition of a fifth tee, and a new fleet of electric golf carts with GPS and live scoring capabilities.

SHOTGUN OR TEE TIME START

To completely close the golf course for your golf outing, a minimum of 100 players would be required. With a smaller group, we offer a modified shotgun start or tee times.

GOLF OUTING PACKAGES

FEES AND PAYMENT SCHEDULE

A \$1,000 down payment is required upon submission of your completed and signed Golf Outing Application/Agreement to guarantee your outing date. This schedule includes charity golf outings. Payment in full is due immediately upon completion of your outing. If hotel rooms are booked as part of the outing, then a 50% deposit will be required at the time of booking. Full payment of the hotel rooms is to be made at check in.

BRISTOL HARBOUR GOLF OUTING POLICIES

DEPOSIT AND GUARANTEE

A guaranteed confirmation for an outing will occur upon receipt of both the complete application agreement and the required initial deposit as stated in the preceding Fees and Payment section of this document. An event will not be confirmed without the required initial deposit as stated above.

CANCELLATION

Inclement Weather: Bristol Harbour Lodge & Golf Club reserves the right to postpone golf outings due to inclement weather. Outing postponements will be the sole discretion of Bristol Harbour Lodge & Golf Club Management. If the event is postponed, the client will be given an opportunity to reschedule the event within 90 days, and the deposit will be held. If a rain date cannot be arranged, the entire deposit will be refunded. If the course is determined playable by Bristol Harbour Lodge & Golf Club Management, no refunds will be issued and the outing will be expected to commence. After two hours of golf, no refunds will be issued.

Refunds: An event may be canceled with or without penalty depending on how far in advance of the event cancellation is received by the club. Refunds on deposits will be made as follows:

- 1) If cancellation is received **61 days or more** in advance of the event: ***Full refund***
- 2) If cancellation is received **31-60 days** in advance of the event: ***Refund 50% of deposit***
- 3) If cancellation is received **30 days or less** in advance of the event: ***No refund***

FINAL PAYMENT ON BALANCE

Final payment of all outing fees is due and must be paid immediately following the conclusion of the event. ***The FINAL GUARANTEE for all golfers, including all outing volunteers, must be due 14 days prior to the event date.*** The guaranteed number is not subject to reduction. Groups arriving with fewer than the guaranteed number of golfers will be charged for the final guaranteed number. Bristol Harbour Lodge & Golf Club reserves the right to only accommodate a maximum of 5% over the guaranteed number of outing participants. BRISTOL HARBOUR GOLF OUTING POLICIES

DRESS CODE AND BEHAVIOR

Gentlemen: All golfers must be wearing collared golf shirts or mock turtle neck style shirts tucked into the waistband. T-shirts, denim jeans, athletic shorts and athletic pants are not permitted. Hats shall be worn in proper, bill-forward manner.

Ladies: Dresses, skirts, slacks, golf shorts, mid-length shorts and blouses are considered appropriate attire. Halter tops, tee shirts, fishnet tops, bathing suits, sweatpants, yoga pants, blue jeans, tennis dresses, athletic shorts or cut-offs are not permitted.

Each player must wear golf or tennis shoes. Bristol Harbour Lodge & Golf Club is a soft spike club - metal spikes are not permitted.

COURSE RULES AND ETIQUETTE

We expect all guests to fix their divots, repair ball marks and display good golf etiquette during the outing. Under no circumstances shall the course be used for practice during the outing.

Each player must have a set of golf clubs when playing the golf course. No more than one player shall play out of one bag. Rental clubs are available.

Behavior that is obnoxious to other players, including the use of abusive/profane language, is not permitted. Anyone deemed to be acting in such a manner will be asked to leave the property.

FOOD AND BEVERAGE SERVICES

All food and beverages must be purchased from Bristol Harbour Lodge & Golf Club. Any outside catering requests must be approved by our staff in advance. **No alcoholic beverages are permitted to be brought on the course. No kegs, personal coolers, or other containers are allowed.**

NEW YORK STATE SALES TAX

All food and beverage charges are subject to change. All food and beverage invoices are subject to New York State sales tax.

REFUSAL OF PRIVILEGES

Bristol Harbour Lodge & Golf Club shall have the right to refuse golf course privileges to anyone, who in the judgement of the club, violates the established rules and regulations as stipulated by the club.

BRISTOL HARBOUR GOLF OUTING POLICIES

PERSONAL PROPERTY

Bristol Harbour Lodge & Golf Club is not responsible for any lost or stolen personal property. Do not leave any valuables in your vehicle during the event.

SIGNAGE

Bristol Harbour Lodge & Golf Club will place and remove at no additional cost, any signage utilized by the tournament. Signage must be claimed by each event and removed from the property at the conclusion of the event. After 72 hours, all signage left beyond that time will be discarded.

OPERATION OF THE GOLF CARTS

Golf Cart Rental Agreement: As the sponsoring organization of a golf outing at Bristol Harbour Lodge & Golf Club, you hereby; (1) agree to hold harmless, indemnify and defend Bristol Harbour Lodge & Golf Club and its owners and agents from and against any and all injuries and damages of any kind whatsoever to any person or entity arising out of or in any way resulting from the negligence or reckless use of operation of the subject golf carts; (2) agree to reimburse Bristol Harbour Lodge & Golf Club for any such injury or damage to any golf carts; (3) agree not to allow any person not of legal driving status to operate a golf cart. Signature of the tournament coordinator on this contract will constitute compliance with the above mentioned golf cart rental agreement.

No more than two golf bags and two riders shall be permitted per golf cart.

Only persons with a valid driver's license are permitted to rent/operate a golf cart.

DAMAGES

We agree to exercise extreme caution when operating equipment (specifically but not limited to golf carts) and utilizing the golf course property. In the event that we cause damage to the property and/or equipment used by our participants, we agree to pay in full for any damages.
